Fales Family Association - 2003 Reunion Maitland, Florida

Minutes - March 1, 2003

The bi-annual meeting of the Fales Family Association met at the Marriott Hotel and Conference Center, Maitland, Florida, suburb of Orlando, FL on March 1, 2003. The meeting was held in the hotel conference room and started at 11:05 AM,

President Allen R. Fales made his opening remarks and invited all present to introduce himself or herself and give a little background on themselves. The thirty people in attendance responded: Allen R. Fales, President FFA, living in Apollo Beach, FL and Isle LaMott, VT; Kay S. Fales, wife of Allen; Jane Roney, living in Orlando, FL; Yvonne Clark, from Kansas City, MO; Esther Fales (cousin of Yvonne) of Palm Harbor, FL; Joe Fales – of Palatka, FL; Betty Fales, wife of Joe; Don Fales – Jane's brother – from Trenton, FL – loves racecar driving and one of original Daytona Racetrack drivers; Kay Fales, wife of Don; Chuck Kamerick – from Plymouth, MA and Venice, FL - has done extensive research on Nova Scotia line and looking for more; Christine, wife of Chuck; John Thomas Fales – historian of FFA and living in New Smyrna Beach, FL; Dorothy (Dot) Fales, wife of John; Richard Fales, from Grand Rapids, MI; Ruth Fales, wife of Richard; Robert McPhillips, husband of Denise; Denise Fales McPhillips, from St. Paul, MN, now living in Largo, FL; Allan (Bud) Fales, brother of Denise – from Minnesota branch of family, now residing in Wisconsin; Irma Fales, wife of Allan; Marlene Marsh, wife of William; William Marsh – wrote article on Vermont line in last newsletter, looking for more info – from Ellenton, FL; Kevin Fales – Membership Co-Chair of FFA – from New York - John T. Fales' nephew; Betty Jean Piccola, wife of Kevin and Co-Chair of Membership Committee; Bernie Bloom, wife of Jerry; Jerry Bloom, FFA secretary from Minnesota branch – currently residing in Door County, WI; Ray and Shirley Kuiper – from Grand Haven, Michigan; Late arrivals in afternoon – Judith Ann Kelle from Florida, with cousins Elaine Elizabeth Fales and Samantha Fales from Ohio

Allen Fales displayed a blue tote bag with the Fales Family Association name on it and said there was one for each person present as a token remembrance of this reunion. He asked all to take one before they leave.

Jerry Bloom read minutes of last reunion from March, 2001. A motion was made they be approved by John T. Fales and seconded by Don Fales. Vote – unanimous.

Treasurer's Report was given – (See Jane Roney's interim report attached). John T. Fales made a motion to accept the report as stated; William March seconded the motion and the vote was unanimous.

Kevin Fales gave the Membership Report. He said there was little activity in 2002, probably due to only one newsletter distributed. He said there are 96 active names on his database, with 44 of them paid through 2002 and 25 renewed for 2003. A list of these members' names and addresses would be available to anyone present who may wish for a copy. See him after the meeting and he will make copies. He stated communication is needed to contact those who have not renewed and was asking how and when this should be done. Discussion was made about sending a second notice in the next newsletter if it comes out in a timely manner – by June.

New business: Jane Roney and Don Fales indicated the lunch would be served during the break around noon. Sandwiches, drinks and the traditional Fales cake would be served. Comments were made that they like the facilities at this location and were thanked for a job well done in planning and organizing the reunion event.

Allen Fales presented a newsletter example from the Sikes Family - another family who communicate updates and historical data from their past. He emphasized that we all need to think about submitting articles for our newsletter, and that they need to be in a completed form. The newsletter editor only is able to edit and format the material and cannot write the articles. All submissions are to go to the newsletter editor, Scott F. It was requested that a standardized heading be developed for the newsletter to be kept the same in each issue. Yvonne offered to coordinate with Allen and present some choices to him. It was also suggested that all officers and their contact phone numbers and/or email addresses be put in all future issues for members and prospective members to be able to contact the association. Also, check with the Master membership list for latest updates and insure your personal information is correct. It is being passed around the table during this meeting. Another suggestion was made to include in future newsletters to announce sub-family reunions when known. Encourage families to send in that information to the newsletter editor.

Old business: A website for the Family Family Association was discussed. Jane Roney informed all that there is a website currently available on www.Ancestry.com with Peter Fales as host. Can we expand his site to use for our purposes, or do we need to develop our own site? We would need to give him direction on what we want and how it is to be acquired and distributed. Yvonne tried to use her laptop to access the site for review during the meeting, without success. An Ad-hoc committee was created to further investigate the Website possibility and make recommendations. Volunteers for this project are Jane Roney, Jerry Bloom, John Thomas Fales, Yvonne Clark, Betty Jean Piccola and Bill Marsh. They will communicate via email to see what can/ should be done.

Lunch break – the meeting was suspended at 12:25 PM for lunch break and resumed at 1:55 PM.

Election of Officers – for 2-year term – Nominations were opened for officer/chairperson positions within the organization. Allen reminded all that spouses were also eligible to run for office. It was gratifying to have so many offers to fill the positions for the new term. A unanimous vote was taken to accept the slate as listed (see below).

John T. Fales then spoke of the origination of the Fales Family Association. John Thomas Fales had written the first issue of the Fales Family Bulletin in November 1982 for his immediate family. Allen got a copy of it and liked the idea. So he held an informal meeting at his home in Apollo Beach, FL and after they got acquainted, created the Fales Family Association. As a thank you for his many years of dedication and leadership within the association, John presented a gift certificate from Barnes & Noble Bookstores as a token of appreciation from all of us.

Then Jane Roney expanded on the historical review of the association. Allen and Kay Fales had invited all the Fales family he knew at that time in 1982 for the first reunion. The next time they gathered was 1985 – at Allen's home. Then in 1986 there were 43 in attendance. In 1988 in Longwood, FL there were 48 present and at that time officially formed the Fales Family Association and elected Allen R. Fales as President. In 1990 there were 33 present. In 1992, 58 people attended a picnic in Palatka, FL. Then in 1995, 28 were there in Chiefland, FL. 1997 reunion was held in Homasassa, FL with 27 members and 1999 was in Dundee, FL. The last reunion in 2001 was held in Maitland with 20 members. She stated there is more than camaraderie at these reunions. It is really more of a "family circle", and a way to keep connected. She presented her scrapbook with reunion info and memorabilia and wants to put it into a published form for keeping together permanently.

Jane then informed everyone that the FFA became a member of the Federation of Genealogical Societies in 2000. As a benefit to being a member, it allows each of us the opportunity to subscribe to their very informative magazine for only \$11/year instead of \$18. She brought several copies from her personal library to show anyone who is interested after the meeting.

John T. Fales then made a presentation of his works with his massive database on the Fales family, started in 1984. From that he published his Fales Family Bulletin, which took all his spare time. In 1993 his interest in songwriting and his condo association sidelined him, but they no longer are an issue and he is back to research on Fales genealogy full time. Besides his database, his personal library includes the complete DeCoursey Fales book, Warren Dexter Fales book and all the FFB publications. He showed his printout of the database in a binder – 413 pages in all, including an index. He wants to publish it in CD format, as the book form is not practical in today's libraries. It would not include any information on living people, except their name. His new printer (Hewlett-Packard #6122) prints his file on double-sided pages. His endeavor is to scan all his FFB issues and put in CD form. Also, create a Fales-finder index of all names in the WDF and DeCoursey books, including birth and death dates.

John then presented packets for each reunion attendee. In each packet was an ancestry delineation of Anne Brock, going back six generations to Thomas Brock b 1448, and d 1503. Also included were personalized pedigree charts for their own personal branch of the Fales family tree. He went on to say that there was a Fales member in every battle in America from the King Philips War on to the present. He warned all to be cautious when finding information on the Internet, as misinformation is being spread (although unintentionally) regarding "James I" parents. No substantiation or documentation can be found regarding his parentage, or that he came from Chester, England. He did state that he has a theory that James may have had a brother named John. Research in land records has a John Faille in Boston that may be the same family. He will continue his research before he publishes the details.

Miscellaneous comments: It was asked that all masters of newsletters for the Fales Family Association be sent to Allen F. Fales as a central repository. Jerry indicated she would send the three issues she had to him. Charles Kamerick stated he has an extensive file on the Nova Scotia branch and would invite all who have knowledge of that branch to contact him. Jerry Bloom demonstrated the techniques of using CDs to capture family images to display as a mini-slide show. It was created using a Hewlett-Packard scanner/printer and HP memory disc creator software. It is easy to use and makes professional-looking package. Jane Roney stated there were three letters on an Internet site for auction for \$6. She will research it and will publish her findings in a future newsletter. Bill Hayden offered to help.

It was then decided to adjourn to the front of the building for a group photo and then to meet in the lobby for dinner at 5PM. The meeting was closed at 3:10 PM.

Fales Dental Soap

These photos are of an item brought to the recent Fales reunion. Don Fales' friend and old

In your reply you mention a land grant of 1160 acres in the Township of Wilmot is dated March 6, 1787, {Nova Scotia Land Grants Book 19 old, page 128} to the Heirs of Benjamin Fales. I cannot find that location on the map, Index sheet #35, Land grants in Annapolis and Kings

County. I do find a old #534, BK 18, P-109 for 500 acres to the Heirs of Benjamin Fales and assume this must be it.

One further question. It is said that on September 21, 1789 That Benjamin Fales and a George Stronach signed a deed purchasing 1000 acres of land owned by Rufus Chandler. old #577, BK 19, P27. A General T. Ruggles may have been involved in the transaction. Where can I obtain formation that will either prove or disprove that this transaction occurred? I have data that says this did happen but your data, Heirs of Benjamin Fales, has him deceased ca 1776 or 77 when his widow filed for a land grant. Dead men cannot sign deeds, but others can use his name.

Dear Mr. Kamerik:

Land Grant book 19 old, page 128, mentions that the land is on the south side of the Annapolis River beginning on lower bound of land granted to Major Farring. It also mentions land bound by Major Johnstone. Book 19 old, page 27, is a land grant of 1500 acres in Wilmot Township to John Chandler and Martha Philips. It is dated December 26, 1787 and registered January 9, 1788.

Due to the numerous inquiries which arrive daily, staff are unable to undertake extensive genealogical searches. You will have a hire a researcher to check Annapolis County deeds and other land grants if you want an extensive search undertaken. A list of professional genealogists is on Nova Scotia Archives and Records Management's web site [www.gv.ns.ca/nsarm]. If you have a local Family History Center (Mormon Church), the Center can borrow Annapolis County deeds on microfilm from the Genealogical Society of Utah in Salt Lake City.
